Previous Complaints

Saturday working at Tower- they are required to notify the council by email before 16.00 on the preceding Friday and only allowed to work up to 26 Saturdays in a year. How many times have they notified RCC this year.

Tower bund penalties or fines for breach of condition relating to height- If the bund has not been undertaken in accordance with plans the matter will be reported to the next DC committee. If it is resolved to take enforcement action for breach of conditions and TRL did not seek to address the matter then the council could pursue the issue through the courts as the council do not have the power to impose fines.

Can the speed limit between the rugby club and Cefn Farm be lowered. Vehicles coming out of Selar are speeding. Cllr. Oliver will bring this up in the next liaison meeting on 22^{nd} July.

The drain in Heol y Bryn near the playground is blocked.- done

The light on no. 10 lampost in Heol Esgyn is out.- back on

The lights do not come back on at 5.00a.m. in Heol y Graig - the light currently comes back on at 6.00 a.m. but when British summer time ends it will revert back to 5.00 a.m.

There are a shortage of houses for single people in Rhigos, RCT need to invest in some 1 bedroom properties in the village. - the reply from RCT states that there is a lack of available development land but there are several pieces of land which could be used.

Trees need cutting back between the cemetery and the New Inn they are overhanging the road. - this has previously been done by a local farmer but the land is privately owned by M Roberts.

The bus shelter by the shop has broken glass in it.

There is a hole in the pavement near the old adventure playground. - done

Temporary road closures from 1st November 2015 - 21st August 2016 for abnormal loads to be delivered to the windfarm

New Complaints

- a. The back of Longmede parc near the seat needs cutting back and there is a gorse bush growing over the sign.
- b. A House Sold sign has been dumped outside the community centre.
- c. Chippings from gardens are spilling out onto pavements making them dangerous.

- i. The drains on the Glynneath bank need cleaning.
- j. There are no drains in Cwm Isaac so the water is running down and breaking up the tarmac.
